

HPM Hawai'i Island Anniversary Giveaway

Sponsor: HPM Hawai'i Island's Anniversary Giveaways are sponsored by HPM Building Supply.

Eligibility: The Giveaway is open only to legal Hawai'i Island residents who are 18 years of age or older at time of entry. - Up to four (4) entries per person, per store, per day.

Participants may better their odds of winning by texting up to four (4) unique keywords per location, once per day. Entrants may submit up to 12 entries per HPM Hawai'i Island store location.

The Winner will need to present photo identification and sign a winner verification form and W9 Request for Taxpayer Identification Number and Certification Form at the confirmed Hawai'i Island HPM Building Supply store.

The Winner's Responsibility: There are no substitutions, exchanges, or transfers of Prizes by Winner. Winner is responsible for all taxes and fees associated with the prize receipt and/or use. Winner must pick up the Prize within 30 days of initial contact or Sponsor will draw another Winner.
