

HPM Lānaʻi Anniversary Giveaway

August 23, 2024 – August 25, 2024

NO PURCHASE NECESSARY TO ENTER OR WIN. MUST BE 18 YEARS OR OLDER AND A MAUI RESIDENT TO ENTER.

Sponsor: HPM Lānaʻi's Anniversary Giveaways are sponsored by HPM Building Supply, DeWalt, Benjamin Moore and Big Green Egg.

Eligibility: The Giveaway is open only to legal Lānaʻi residents who are 18 years of age or older at time of entry. - Scan the QR code and submit the form.
- OR fill out the manual entry form in-store.
- Each form submission counts as one (1) entry.
- One entry per person, per store, per day.
- Participants may better their odds of winning by submitting one (1) entry per day. Entrants may submit up to three (3) entries.

The Giveaway runs August 23, 2024 through August 25, 2024. 3 winners will be randomly selected to receive one of the prizes, including:

The Winner's Responsibility: There are no substitutions, exchanges, or transfers of Prizes by Winner. Winner is responsible for all taxes and fees associated with the prize receipt and/or use. Winner must pick up the Prize within 30 days of initial contact or Sponsor will draw another Winner.

Publicity: Except where prohibited, participation in the Giveaway constitutes the entrant's consent for Sponsor to use the Winner's name and photo for promotional purposes in any media without further consent. A media release form will be presented along with the winner verification form.
